As per permission accorded vide Lr.No. U. 12012/127/2004-ME (P-II), dt. 13-07-2007 by the Ministry of Health and Family Welfare Department of Health Government of India, New Delhi, and as per the orders of the Vice-Chancellor, Dr. NTR University of Health Sciences, vide reference 4th cited, and as per statute on affiliation of Medical Colleges of Dr. NTR UHS., Vijayawada, it is hereby certified that the application of Shadan Educational Society, Hyderabad for granting provisional affiliation for starting of Final MBBS Part-I Course during the academic year 2007-08 and also provisional affiliation is granted for the academic year 2007-08 permitting to make admissions at Shadan Institute of Medical Sciences (SIMS) Teaching Hospital & Research Centre, Peerancheru, Hyderabad with an intake of 100 students (one hundred only) as per rules.

The No. of students admitted do not exceed the number of students permitted for annual admissions both under free and management quota as specified by the Government of Andhra Pradesh / Dr. NTR University of Health Sciences.

The fee collected by whatsoever name billed either for free seats or for management seats do not exceed the limits specified by the Government of Andhra Pradesh / Dr. NTR University of Health Sciences from time to time.

The management of the College shall follow the regulations made by the University / Government of Andhra Pradesh in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation in this regard may lead to disaffiliation of the college without any notice.

The institution shall abide by the statute / Admission Rules & Regulations etc., of Dr. NTR University of Health Sciences, Vijayawada.

The management of the college shall rectify the deficiencies pointed by the inspection committee which were enclosed as annexure and submitted the compliance report to the undersigned.
